**MINUTES OF PREVIOUS COMMITTEE MEETING** held on 5 February had been distributed to Committee members. The tree inspection that was due on 31 January was not carried out since the inspection team had not visited Freemen sites. **SM** had the measurements for the new H & S noticeboards.

## **COMMUNITY PLOT UPDATE**

Rich Littlewood joined the meeting at 5.45 p.m. He confirmed that the group had decided to use a single plot for the project and that digging had begun; he was advised to clear the plot in the first instance. The sub-group would need some financial help to erect fencing between the adjoining plots. It was agreed that members would be notified via the website that the scheme was going ahead; members would be able to opt not to receive emails about the scheme if they did not wish to do so. Progress would be reported monthly on the website and via Facebook and events would be posted on the noticeboards.

## **SECRETARY'S REPORT**

**KG** had received notification for renewal of membership of the National Allotment Society. Members receive a quarterly magazine, a discounted seed scheme and information and advice through the NAS website; at £3 per member, this still represents good value for maoney.
